**APPROVED WORDING FOR SIGNS TO CONTROL
UNAUTHORIZED TRESPASSING, PARKING OR SKATEBOARDING
ON PRIVATE PROPERTY**

The City of Redding and the State of California have policies regarding the placement of signs on private property which will allow police representatives the authorization to issue citations, tow and/or arrest violators on behalf of the property owner.

Approved wording for the signs is as follows:

Private Parking

PRIVATE PARKING
Unauthorized Parking Prohibited by Law
Violators Will Be Cited or Towed Away
Redding Municipal Code 11.24.260
Redding Police Department 225-4200

The above Private Parking sign must meet the below specifications Per CVC22658(a)(1):

- ✓ At least 17 inches wide x 22 inches high
- ✓ With lettering not less than one inch in height
- ✓ Posted conspicuously at all entrances to the property (RMC 11.24.260 (A))

Trespassing

PRIVATE PROPERTY/NO TRESPASSING
Violators will be prosecuted under the provisions of
Section 602 California Penal Code
forbidding Criminal Trespass
Redding Police Department 225-4200

Any City of Redding Police Officer may issue a citation and/or arrest a violator of the above listed codes, provided the signs are posted as outlined and a consent to enforcement form has been executed.

If a criminal complaint is issued under these sections, the owner may have to appear in court. Further information concerning the procedure for police enforcement may be obtained by calling the Redding Police Department Administrative Sergeant at (530) 225-4292.
